


GOAL: Enhance the use of PRTR data for tracking pollutants across borders.

Activities:

- 1. Review CBT data reported by NA sources (latest 3 years in *Taking Stock*):
 - ✓ Facilities, sectors, pollutants, amounts, and transfer types
 - ✓ Identify data quality/comparability gaps and issues *focus within NA*.
 - Assess the accuracy of reported information, recipient country reporting requirements, etc.
- 3. Recommend potential areas for improving CBT reporting.

- 3. Develop report to support recommendations for CBT data quality improvements.
